ORDER

This matter is before the Court on Defendant's Motion to Set Final Date for Posting Surety Bond and Plaintiffs' Motion to Reconsider Injunction Bond and Amount Thereof.

Having considered the papers and the arguments of counsel, and for good cause shown, the Court orders that:


1. Defendant's Motion to Set Final Date for Posting Surety Bond is GRANTED. Plaintiffs are ORDERED to post the \$10 million surety bond, if at all, on or before November 15, 2007 at 4:30 p.m. The Clerk is directed not to accept a bond after this date and time. If the \$10 million surety bond is not posted by this date and time, the temporary injunction entered against Defendant on November 10, 2007 shall be dissolved as a matter of law.

2. Plaintiffs' Motion to Reconsider Injunction Bond and Amount Thereof is DENIED.


3. The Clerk shall send a certified copy of this Order to all counsel of record.

IT IS SO ORDERED.


